American Checked, INC. will also disclose the recipients of any such reports on me which AmericanChecked, INC. has previously furnished within the two year period for employment requests, and one year for other purposes preceding my request.

I authorize AmericanChecked, INC. to conduct such reports about me and furnish the above-mentioned information to the Diocese for its use in determining my suitability as an employee and/or volunteer . If accepted as an employee and/or volunteer, I understand this disclosure and authorization shall remain on file and shall serve as an ongoing authorization for the procurement of such reports at any time during my employment and/or volunteer period.
